1. It appears the VA is under the impression that the Army automatically furnishes pay data on each VA Form 3101 which is marked "Death". (Incl 2), however, the only time pay data is furnished is when the VA specifically asks for such data or where they have indicated that "PLSBI" is involved (Incl 3).

2. If USARGEN was to furnish pay data on all VA Forms 3101 where the type of claim is marked "Death" and Item 3 is checked in the block entitled "service", approximately 4,000 additional cases a month would be processed in USARGEN for pay data, and subsequently forwarded to the Army Finance Center.

3. If USARGEN is to furnish pay data on the VA Forms outlined above, then it is recommended that under Item 1 (Type of Claim) "PLSBI" be entered on each pertinent form. This would easily identify those cases and would assist in processing the reply. (PLSBI cases are handled on a higher priority than the other VA Forms 3101).

4. Present procedures will be continued until we are notified otherwise.

Dear Sir:

In accordance with an existing agreement between the Veterans Administration and the military services, your Department automatically furnishes basic pay and rank or pay grade at date of death or separation from last period of active duty in response to the "Death" legend in Block 1 of VA Form 3101.

Our experience of recent months indicates that many "Death" Forms 3101 are submitted to your Department to obtain medical information only; pay data already having been received on casualty reports or by other means.

To relieve you of the burden of supplying pay data which is already on file in the VA, and to expedite completion of action in these cases, we request that your Department hereafter furnish pay data in response to the "Death" legend on VA Forms 3101 only when the "Service" block is checked in item 3, "Data Requested", or when a specific request for pay data is entered in item 21, "Additional Information Requested."

A copy of any instruction issued will be appreciated.
