1. For the purpose of compiling various statistics on completed VA 3101 cases, the following instructions will be followed during the 30 day period commencing 20 May 1957 and ending 19 June 1957, unless otherwise notified:

2. Action by Records Section. a. The file searcher will search for a file

~~Guerrilla cases~~ only under the name shown on the VA 3101 request. The appropriate search report will be placed on the reverse side of the VA 3101, e.g., 1 record attached only one found, or no record found.

b. The case will then be forwarded to the archive clerk for a search of the guerrilla IBM cards and rosters.

c. The archive clerk will verify the guerrilla IBM cards and/or rosters for the name shown on the 3101 or a variation thereof. If ^ano reference to the name is located, a negative report will be placed on the reverse side of the 3101 request. ^{2 of}

d. If a reference is found on the ^{guerrilla} IBM card or roster by the archive clerk, he will initiate an ARGEN Form 646 report on the individual. The case will then be returned to the file searcher for a ~~negative~~ search of the name shown on the guerrilla roster. ^{negative search procedure, if}

e. ~~If a negative report is made on the VA 3101~~ the case will be forwarded direct to the Chief, VA Section for action.

e. ^{Upon completion of cases} Cases requiring a negative search will be forwarded to the ^{Chief} VA Section, Chief after the search is completed.

f. The foregoing procedures apply only to VA 3101 requests for verification of guerrilla service. Those requests involving alleged PA USAFFE service will be searched in usual manner.

3. Action by VA Section. a. Claims examiners in VA Section will process the cases in the usual manner except that a report will be made on each individual VA 3101 request.

b. The claims examiners will prepare the report to indicate the number of new files created; number of cases processed with incomplete files; service claimed; and service determined.

c. The reports should be prepared in a uniform manner on a separate sheet of paper for each case.

d. The attached sample report is furnished as a guide to claims examiners. ~~in preparing these reports.~~

1. For the purpose of compiling various statistics on completed VA 3101 cases, the following instructions will be followed during the 30 day period commencing _____ and ending _____, unless otherwise notified.

a. Cases involving only Guerrilla Service. (1) The file searcher will search for a file only under the name shown on the VA 3101 request. The appropriate search report will be placed on the reverse side of the VA 3101, e.g., 1 record attached - only one found, or no record found.

(2) The case will then be forwarded to the archive clerk for a search of the guerrilla 184 cards and rosters.

(3) The archive clerk will verify the guerrilla 184 cards and/or rosters for the name shown on the VA 3101 or a variation thereof. If a reference to the name is not located, a negative report will be placed on the reverse side of the 3101 request and the case will be forwarded direct to the Chief, VA Section for action.

(4) If a reference is found ^{by the archive clerk} on the guerrilla 184 card or roster, ~~by the~~ he will initiate an ARGEN Form 646 report on the individual. The case will then be returned to the

file searches for a search of the name shown on the guerrilla rosters and negative search procedure. After the appropriate search is completed, the results will be listed on the reverse side of the VA 3101 request and the case will then be forwarded ~~and~~ to the Chief, VA Section for action.

b. Cases Involving ^{PA} USAFFE or ^{PA} USAFFE Guerrilla Service. Those VA 3101 requests involving alleged PA USAFFE service will be searched in the usual manner.

2. Based on the foregoing instructions, a daily report will be maintained by the Chief, Records Section to be turned in ^{to} Branch Headquarters at the end of the test period. The reports will include the following information:

- a. ^{Total} Number of 3101 cases from 201 files to archives.
- b. Number of 3101 cases from 201 files to archives (No name on roster)
- c. Number of 3101 cases from archives to 201 files (additional search and original)
- d. Number of 3101 cases from archives to 201 files (add search and 201 as found)
- e. Number of 3101 cases without 201 file and a similar name is listed on roster.

3. It is realized that all cases forwarded to archives from the 201 files will not be processed on the same date they are forwarded. In order that an accurate tabulation may be made by the Chief, Records Section, it will be the responsibility of the file searcher to place a 3x5 control slip
