BIRTH DATA ON VETERANS ADMINISTRATION INQUIRIES



2. Recovered Personnel Records Branch Memorandum Number 12, 20 October 1958, Subject: Birth Data on Veterans Administration Inquiries, is rescinded.

3. Effective this date it is no longer a requirement to verify birth data on Philippine Army, USAFFE or Guerrilla service verifications unless a specific request is made for such information in item 21 of the VA Form 3101.

4. The Veterans Administration Manila Regional Office will continue to enter birth data in items 10 and 11 of the VA Form 3101 for the benefit of this office in establishing identity.
