1. Attention is invited to the attached copies of TWX messages from ^{Mr.} Belnap. ^{These messages concern} regarding TWX requests for extension of deadline dates on correspondence cases designated as deadline or mail control slips.
2. It is suggested that coordinating action be taken with Washington to set up a code system on TWX requests for extension of deadline dates on correspondence. ^{This proposed coding system could be set up} similar to that ~~used~~ used on Burial Cases (QMG). This would simplify the preparation of such TWX messages and reduce costs.
3. Based on Mr. Belnap's message number 5, 19 September 1957, there are five items to be reported on messages requesting extension of deadline dates as follows:
 - a. Name of veteran
 - b. Mail control number
 - c. Deadline date

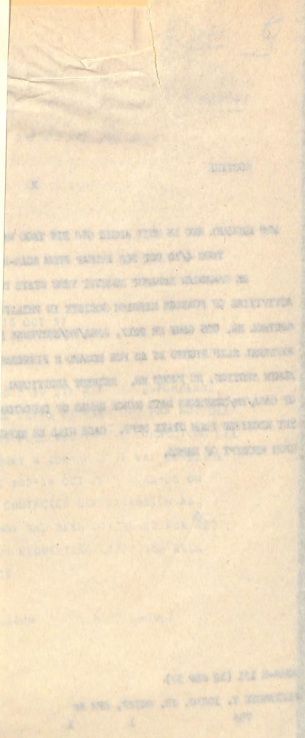
