MEMORANDUM FOR: General Benedict.

SUBJECT: Proposed Circular Regarding  
Accounts of Civilian Employees  
During Absence in Status of  
Missing, etc.

1. I concur in the changes in the proposed circular suggested by the War Department Dependency Board.

2. A copy of the proposed circular was submitted directly to the Casualty Branch for comment or concurrence and was returned with a substitute draft (copy of which is attached) in which were incorporated (in somewhat different phraseology) changes substantially the same of some of the changes suggested by the Board. The language used in all changes suggested by the Board appears to be entirely satisfactory.

3. One item incorporated in the Casualty Branch draft and not included in the Board's memorandum is a suggested change in paragraph 5 c to provide for submission of two copies, instead of one copy of the supplemental report; the thought being that some of the data in the report would be useful to the Casualty Branch and that a copy should be retained in the files of the Branch.

4. Appropriate notation has been made of your suggestion for inclusion in the next amendment of the Casualty Circular of the quoted material in paragraph 10 of your memorandum.
