AUS status

2 allege AUS induction at Aritao into units existing  
only in the Pincappagan area - not possible.

6 1945 processing records show they were civilians not  
on duty as of 14 July 42.

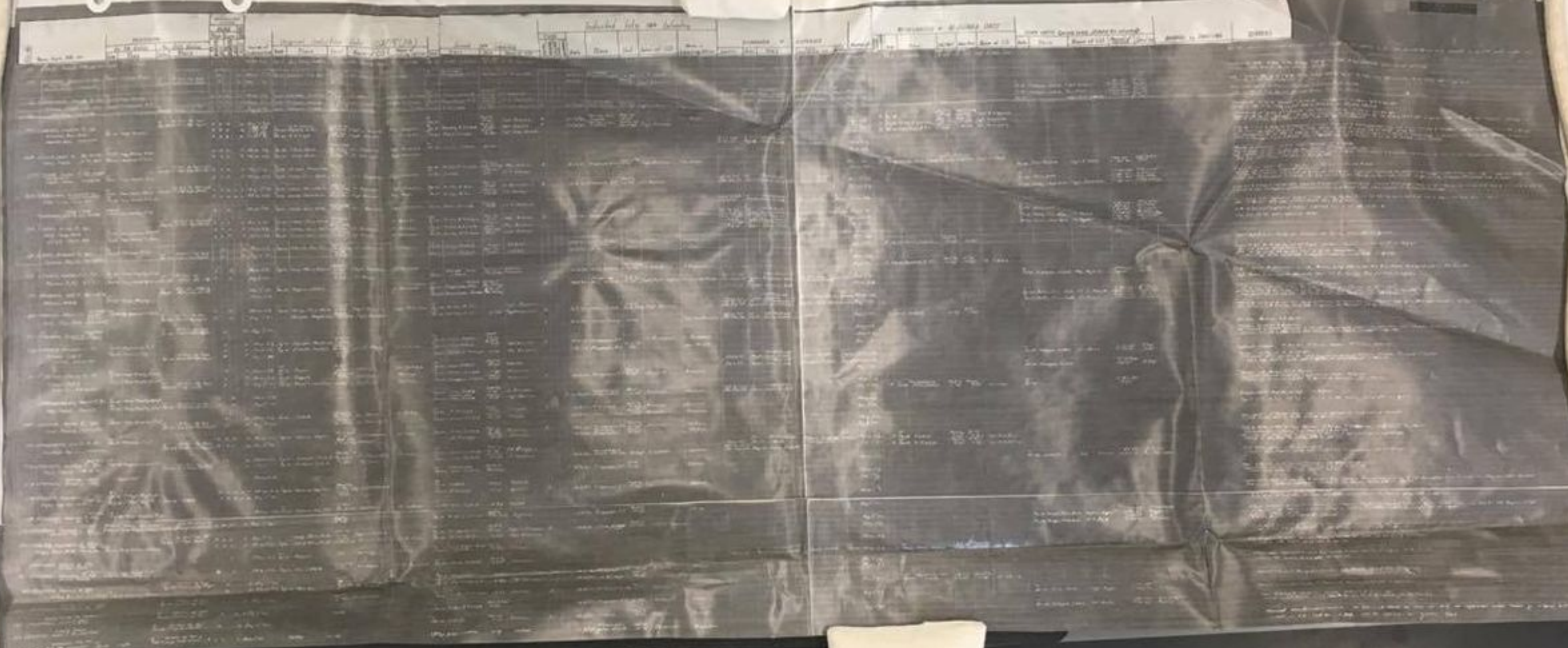
