TO : Commanding Officer, 343d Infantry, APO 450.

1. Inactivation Order #15, this headquarters, dated 31 January 1946 is rescinded.

2. Pursuant to the provisions of Par. 3, Ltr, Hq AFWESPAC, APO 707, "Demobilization of Philippine Army", GSCPO 091 PI, dtd 6 Dec 45, and GO, HPA, as indicated, subj: "Inactivation and Disbandment of PA Units", the following named units were disbanded as of date shown herewith:
