

One individual also has mimeographed copy on file, while two others submitted true extract copies of same Special Orders as evidence of discharge. 201 files for six individuals contained Reports of Physical Examinations prior to discharge, dated 23 Jan 46.

3. Command line, name and signature of Vicente Belen, Capt, Inf PA, Adjutant, shown on Special Orders in question, are consistent with other Special Orders of same organization on file in Records Section, RPRB.

4. It has been noted that the effective date 31 Jan 46, on mimeographed copy of orders involved, is entered in ink over the original typewritten date. 



