1. This project initiated to verify authenticity of mimeographed copy of SO #51, Hqrs (orgn not shown - probably 2d Mil Dist), AFP, Camp Ord, Tarlac, 4 Dec 47, located in 201 file for Moises V. Aboy, 490 719. Orders list names of 25 PAP and contain evidence of their reversion to inactive status and/or discharge from AFP on 4 Dec 47.

2. A search of PA special order files in Rec Sec, RPRB, failed to locate any special orders for 2d Mil Dist, AFP, Camp Ord, Tarlac. An examination of 201 files for 25 PAP listed failed to reveal any other copy of orders in question. Only two individuals alleged being discharged 4 Dec 47, and only two files contain Forms 38, dates of which are shown as 22 and 25 Nov 47. The other files do not contain any information pertaining to date of discharge shown in orders. However, all Forms 23 in 201 files are dated during period 11 Nov 46 thru 24 Nov 47 (9 dated 11 Nov 46), and show Processing Unit as 2d Mil Dist, AP. About one third of the 25 on same Forms 23 claim guerrilla service and alleged being released or discharged during period 15 Mar 45 thru 30 Dec 45, with majority alleging 28-30 Dec 45.

3. Examination of Forms '23 and affidavits in 201 files also revealed that 12 individuals alleged induction into USAFFE by Maj. Reynolds on 8 Dec 41 for service with 86th FA (PS), as drivers, mechanics, and other various occupations (neg in civ files). All allege they were separated from said unit o/a 24 Dec 41, and returned home shortly thereafter. None of these individuals claimed guerrilla service. Aforementioned affidavits submitted in their cases are all mimeographed copies dated 28 Nov 46 and 20 Feb 47, executed by same two affiants, and with exception of subjects' names and occupations, are exact duplicates. Individuals concerned not listed on available payrolls for 86th FA (PS).

4. The name of Lt. Col. Ausejo shown in command line on orders involved has been identified as Lt. Col. Placido A. Ausejo, O-1213. Correspondence in his 201 file indicates he was District Commander for 2d Mil Dist, Camp Ord, Tarlac as of 23 Oct 47. The name and signature of N. D. Carreon, Major, Inf, Adjutant, appears to pertain to Maj. Numeriano D. Carreon, O-1232. His file contains medical records dated 23 Dec 47, showing his rank and organization as Major, 2d Mil Dist, Camp Ord, Tarlac.

5. Although the complete name of organization involved is not legible, the evidence contained herein indicates that SO #51, dtd 4 Dec 47 is an official document issued by Hqrs 2d Mil Dist, AFP, Camp Ord, Tarlac. These orders, issued almost one and one-half years after the separation of the Philippine Commonwealth Army from the Armed Forces of the United States, do not contain any pertinent evidence of service prior to 30 Jun 46, and would not materially affect determinations of service alleged prior to 30 Jun 46. The alleged earlier dates of discharge or release (Mar-Dec 45), as noted in Par 2, and lack of acceptable evidence in


