1. This project initiated to locate the original or mimeographed copy of GO #2, Hqs 71st FA (PA), Office, Regimental Commander, Camp del Pilar, FSR, Pampanga, 4 Nov 41. Attached true copy of orders lists names of 53 PA officers and contains information pertaining to assigned duties with 71st FA. Name of Commanding Officer is shown as H. C. FOWLER, Major, FA. Document certified as true copy by Oseas Del Rosario, O-27 759, 2d Lt, Inf, Administrative Officer, 26th Sta Hosp (PA).

2. No other orders for same organization located on file in Records Section, RPR Branch. Search of 201 files for officers listed on orders failed to reveal the original or mimeographed copy of orders. However, 10 files contained similar true copies or true extract copies of orders involved.

3. Information in 201 files shows that 50 of the 53 officers listed have been certified positive for USAFFE (VA-WCC or both), and remaining three have sufficient archives to establish the same. Approximately 90 per cent have archive evidence prior to date of orders. (Listed on Roster of Officers, 71st FA Regt, 30 Sep 41 - joined 3d) Consequently, the orders are not necessary to establish USAFFE service, and with a few exceptions, would not be a prime factor in determining beginning dates of such service.

4. Although no contrary evidence has been revealed, the absence of the original or mimeographed copy of orders involved, leaves no basis upon which to establish document as an authentic copy of the original. In line with the policy of this office of not accepting true copies in lieu of original military orders, the attached copy of GO #2, Hqs 71st FA (PA), 4 Nov 41, cannot be accepted as an authentic official document. Also, as noted in Par 3, it appears that, with a few exceptions, the orders would not materially affect determinations of USAFFE service for individuals listed thereon. In view thereof, suggest no further effort be made to locate original or mimeographed copy of General Orders in question. Recommend that, for reference purposes, a Memo be placed in USAFFE Decimal File 330.32, Folder 35 (Roster of Officers and EM, 71st FA), and in Historical File of 71st Div, concerning location of this study and the action taken.
