1. This project initiated to verify authenticity of Par 1, SO #268 and 269 Hqrs USAFIP-NL, Advance Echelon, 12-13 November 1945. Orders list the names of 115 PAP and contain authority for their discharge from the PA effective 20 November 1945.

2. A comparison of these orders with other orders issued by same organization during Nov 1945, on file in Records Section, RPRB, reveals that the format, numerical sequence, command line and signatures of Pedro G. Simon, Capt, Inf PA, Asst. Adj. General, are compatible.

3. 201 files for 25 individuals listed on orders have been examined. Alleged ranks, service numbers and organizations correspond with orders in question. Only eleven files contained information pertaining to date of discharge. Ten alleged discharge during period 15-20 Nov 45, five of which submitted true extract copies of orders involved. One alleged discharge 27 Nov 45.

4. Eight of the 201 files examined (PAP listed on Par 1, SO #269) contained WD AGO Forms 38 dated 26 Nov 45, indicating possibility that individuals were still in service as of that date. However, no record has been found to show that orders were amended or Any names deleted therefrom. SO #290, same organization, 20 Dec 45, containing amendments and deletions pertinent to SO's 266 through 289 fail to show any information concerning orders in question. 201 file for one individual involved contains 1st Ind, Hq Combat Co, 11th Inf dated 28 Nov 45, to Hq 2d Inf Div, PA, showing soldier honorably discharged per SO #269 dated 13 Nov 45, left his organization 27 Nov 45, and was last paid to include 19 Nov 45.

5. The evidence indicates that documents involved are compatible with other orders issued by same organization and with information alleged by PAP listed.
