2. Organization, location, numerical sequence, and name of Luis Ramos, Colonel, AGS, The Adjutant General, are compatible with other orders issued by same organization during December 1941, on file in Records Section, RPR Branch.
3. 201 Files located for 11 of 16 individuals listed. All contain copies of orders involved. Six files contain positive certifications of USAFFE (VA or WCC), and one file indicates sufficient archives (NSLI-WD Cas Report with NOK), to establish the same. Alleged home address, date and place of induction, appear to be consistent with address, date and place of call to active duty shown in orders. With one exception, alleged organizations (components of 1st Reg Div) correspond with unit assignment.
4. Effective date and place of call to active duty is also consistent with GO #47, Hqs USAFFE, 19 December 1941, and history of 1st Reg Div regarding date and place of mobilization and induction. (Ref: USARCEN SOP APP 18).
5.
