2. Signature of "Juan K. Taduran" C.O. appearing on roster in question is compatible with signatures found in the 201 file. He alleges to have been the Commanding Officer of the 73d Inf. Regt. A Record of Events and Strength Return of "C" Co., (73d Inf Regt) Magallon, Neg. Occ., dated Sep 30, 1941, located in the 201 appears to be part of roster under study. Information and other identifiable marks appearing on Record of Events and Strength Returns are comparable to roster.
