1. This project initiated to verify the authenticity of P/R's, Capiz Co, P.C. for the month of Jan and Apr 1942 and their value as USAFFE - PA Archives.

2. Eighty-seven (87) files were drawn. The majority of files studied allege induction by Col. Thayer, AUS, on 30 December 1941 and show their organization as Capiz Co, P.C., commanded by Capt. Janairo and/or Maj. Gatuangko. They further allege unit disbanded 30 May 1942 and most individuals allege later joining the guerrilla of the 6th Military District.

3. The 201 file of Lt. Col. Antiquio X. Janairo, shows allegations that he was the Commanding Officer of Capiz Co, P.C. from 1 Jul 1941 to 31 December 1941. Inducted into the USAFFE by Col. Thayer on 29 Jul 1941 (Month of induction is believed to be in error.) 1 Jan 1942 to 15 Feb 42 Executive Officer of the 64th Inf. Regt. (PA) and Commanding Officer thereof from 16 Feb 42 to date of surrender 30 May 1942. Subject's service is established by G.O.s, NSLI and POW archive records.

The 201 file of Col. Constancio V. Gantuangko, shows allegations that he was inducted into the USAFFE on 17 Nov 41, assigned Adj. Gen. of the 61st Div. (PA) and Commanding Officer of Capiz Co, P.C. from 17 Nov 41 to 27 May 42. Affiants in file testify subject was assigned Commanding Officer of the Capiz Co, P.C., in the later part of December 1941. His USAFFE service has been certified to the VA based upon pre-war archives and payrolls in question.

P/R's show and are signed by Benjamin S. Empestan, Disbursing Officer, Phil. Army. His 201 file shows allegations that he was inducted into the USAFFE on 15 December 41. From 2 Jan 42 to 30 May 42 he was assigned with Fin. Sec, 64th Inf, 61st Div (PA) and Lt. Col. Janairo was his Commanding Officer. Organized guerrillas from date of disbandment. Subject signs his name on various P/R's of the 64th Inf, from Jan 42 thru May 42 as Disbursing Officer and appears on a G.A.D. roster of Dist. Fin. Sec., 6th M.D. Signature on P/R's in question are compatible with signature in 201 file (see Ltr dtd 27 Sep 47). *Incl 114*

The 201 file of Enrique P. Dureza, shows allegations that he was a member of the Capiz Co, P.C., from 1 Jul 41 to 5 Jan 42 and with Hq & Hq Svc Co, 61st Div (PA) from 6 Jan 42 to date of surrender. His USAFFE service is established by POW archive record.

4. Payroll dated Apr 42, signed by Maj. C. Gantuangko, lists three (3) names as attached. Two (2) files have been located and show the following:

a. Celistino A. Austin, alleges induction into the USAFFE on 12 Dec 41, attached to P.C. Det, at Palawan. 10 Feb 42 on way to Panay. Attached to Capiz Co, P.C., 11 Apr 42.

b. Russell C. Tordesillas, alleges induction into the USAFFE on 11 Jan 42. Served with the M.T. Co, 61st Div (PA). After the Japs landed in Capiz he reported to

Col. Janairo, Commanding Officer of the 64th Inf Regt (PA).

c. No file has been identified for Carlos De Leon.

5. Thirty-two (32) files have been certified to the VA, seventeen (17) living, fifteen (15) deceased. Claims were certified as follows:

Twenty-five (25) positive for USAFFE and Guerrilla service.  
One (1) positive for USAFFE, negative for Guerrilla service.  
Two (2) positive for USAFFE (KIA Apr 42)  
Four (4) negative for USAFFE, positive for Guerrilla service.

Three (3) files contain VA insurance claims in which military services were certified as follows:

One (1) positive for USAFFE and Guerrilla service.  
Two (2) negative for USAFFE, positive for Guerrilla service.

6. With the exception of three names listed under heading "attached," names listed in page one and two of Apr 42 P/R appear in 8 Jan 42 P/R.

P/R dated 8 Jan 42, shows Antiquio X. Janairo, Capt. Inf, P.C., USAFFE, Commanding, Capiz Co, P.C.

Apr P/R's show station as 64th Inf C.P.

A copy of page three (3) of Apr 42 P/R (242.5) Folder #14 is also in Folder #19, with notation "not to be extracted." It is also noted that the headings are not compatible, "of the Capiz Company, (PC)" appears to have been added at a later date to P/R page three in Folder #14.

7. A search of available archives for the Capiz Co, PC has been made in Records Section, RPR Branch. <sup>Search</sup> This revealed the following:

a. There are no archive records pertaining to the Capiz Co, P.C. other than payrolls.

b. Some members of the Company appear in pre-war P.C. archives (G.O.).

c. Pre-war P.C. Units, District of Visayas lists a 1st and 2nd Capiz Company.

d. Historical data of the 61st Div. (PA) shows Col. Allen Thayer, AUS, Commanding Officer of the 62nd Inf. Regt. (PA) and Capt. Antiquio Janairo as Executive Officer and Commanding Officer of the 64th Inf. Regt. (PA).

e. 64th Inf. Regt. surrendered on 30 and 31 May 42.

f. Forty-one (41) of forty-five (45) individuals with a Fm-646 (Archive Search Rpt) in file are listed on a G.A.D. Roster of the 6th Military District Guerrillas.

g. A spot check of Guerrilla archives 201.35 consolidated personal data of enlisted men, Companies A, B, C and D, 66th Inf, ~~Ct~~, 6th MD lists twenty-five (25) of the individuals shown on P/R's in question as regular members of the P.C. inducted into the USAFFE in Dec 41.

8. Discussion:

a. List of Pre-war Philippine Constabulary Units, District of Visayas, lists a 1st and 2nd Capiz Company. History of the 61st Division (PA) shows Col. Allen Thayer, AUS, Commanding Officer of the 62nd Inf Regt. and a Capt. Antiquio Janairo, Executive Officer and Commanding Officer of the 64th Inf. Regt. (64th Inf was in the same immediate geographic vicinity of the Capiz Co, P.C.). Capt. Janairo alleges to have been the Commanding Officer of the Capiz Co, P.C. from 1 July 41 to 30 Dec 41. (Several individuals alleged service with the Capiz Co, P.C., and subsequent transfer or attachment to some unit of the 64th Inf. Regt. (PA)).

b. Signature of Capt. Antiquio X. Janairo and one Benjamin S. Empestan, Disbursing Officer, appearing on P/R's are compatible with signatures found in respective 201 files.

c. Twenty-nine (29) of thirty-five (35) certifications to the VA were certified as positive for USAFFE service. (26 of those individuals were also certified as positive for Guerrilla service with the 6th Military District)

d. A spot check of Guerrilla archives of the 1st Bn, 66th Inf. Ct, 6th MD (201.35 consolidated personel data) discloses the names of twenty-five (25) individuals who are also listed on Capiz Co, P.C. P/R's. Archives show remarks concerning USAFFE induction in December 1941. (Further search of Guerrilla archives for other names listed on payrolls were not made.)

9. Recommendation

Recommend that Capiz Co, P.C. (PA), payrolls, dated January 1942 and April 1942 be accepted as authentic and remain in USAFFE-PA Archives as 242.5 Folder #14 and 15. Further recommend that a copy of this study be placed in Historical File Folder 69-S, for ready reference purposes.



There is no historical data showing whether or not the Capiz Company, Philippine Constabulary, members were inducted into the USAFFE. Therefore, ten (10) Philippine Army 201 files were called in to check for proof of induction. The attached sheets show a summary of the action taken when requested by the Veterans Administration and War Claims Commission.

As indicated in attached resume, proof of induction of members of Capiz Company, Philippine Constabulary, is not shown in the PA 201's of those persons checked.

of Eduardo Basa was based on his name listed on the Capiz Company, PC,  
payrolls and affiants Jolo, who was an EM listed on the same payrolls as  
S/I, and Esteban Aranda, an officer who states he was a member of a  
different regiment.

That I was a member of Capiz Co. P.C. with the rank of Sergeant;

That I know personally late Pfc JESUS RUBETE to be a member of the same Unit inducted into the USAFFE on December 30, 1941 by Major Allen Thayre USA at Capiz, Capiz;

That the Capiz Co. P.C. was attached to 64th Inf Regt., 61st Div. USAFFE under the command of Lieut-Col ANTIQUIO X JANAIRO;

That on April 16, 1942, I was detailed by Lieut. Yap, our Platoon leader with 5 EM to reconnoit the road from Tapaz to Dumalag. to verify report regarding the approached of the enemy coming from Capiz. At about 3:30 PM we sighted a number of penetrating Japanese forces. I immediately ordered my men to withdraw and report the advancing Japanese forces. In our withdrawal, I saw Pvt Alamis with some soldiers resting in a bushy place at barrio Taft, Tapaz and inform me that Lieut Sanches, Pfc's Jesus Rubete and Herman Abalayan were killed during their encounter in said barrio between the Japanese advancing patrol coming from Iloilo and Capiz. I advised my companion that if possible we will recover the dead bodies of our fallen comrades as there was no more firing. As soon as we were in the position to take hold the cadaver of Pfc Jesus Rubete who was also a member of our Company, we sighted at about 500 yards an approaching motorized enemy Units and a machine gun burst was heard. So we decided to leaved the cadaver and retreated to our security area.

That I enlisted in the Capiz Co., P.C. on June 1941 with the rank of Private;

That I know personally late Pfc JESUS RUBETE to be a bonafide member of the Capiz Co., P.C. The unit as a whole was inducted into USAFFE on 30 December 1941 and later attached to the 64th Inf. Regt. 61st Div. USAFFE. Lt-Col ANTIQUIO X. JANAIRO was the Reg'l Comdr;

That on 16 April 1942, when the Japanese landed Capiz, Lieut. Sanches and a squad of regular soldiers was ordered by Col. Janairo to reconnoit Tapaz-Calinog road. Late Pfc's JESUS RUBETE, HERMAN ABALAYAN, myself and 5 other EM were the members of the squad;

That we reconnoitered as far as Taft, a barrio of Tapas in going to Calinog and right in that place we were intercepted by advancing Japanese patrol. We were ordered by Lieut Sanches to deploy and fought the enemy. After a short encounter Pfc JESUS RUBETE who was 5 meters away from me at the right was hit right at the breast. He fell dead ahead of Lieut Sanches and Pfc Abalayan. We sustained firing but due to great number of enemy reinforcement that simultaneously attacked us, we remaining members of the squad were forced to retreat leaving the cadavers of the late Lieut Sanches, Pfc's Rubete and Abalayan unrecovered.
