1. This project initiated to verify authenticity of Par 9, SO# 224, Hq 2d Mil Dist, Commonwealth of the Philippines dated 9 Oct 41. This extract of SO#224, submitted in the case of Emilio R. Cayabyab, contains names of 120 PA enlisted reservists called to active duty effective 1 Nov 41 for assignments with Companies E, F, G and H, 21st Infantry Regiment. (30 assigned to each company)

2. A search of approximately 40 names listed resulted in location of 30 files pertaining to individuals shown in orders. Examination of these files revealed a general consistency with orders regarding alleged rank, organization and date of induction. No mimeographed copy of orders found in 201 files. One file contained true copy of orders.

3. A comparison of Par 9, SO#224 with other paragraphs (3 & 10) of SO#224, on file in Records Section, shows they are compatible regarding format, organization title, location, date, command line, and signature. Numerical sequence of Par's 9 and 10 also appears to be compatible since Par 10 pertains to Companies I, K, L and M, 21st Infantry Regiment and also shows effective date of call to active duty as 1 Nov 41.

4. Recommend that Par 9, SO#224 be accepted as authentic, that orders be indexed, cards filed in Master Card File, and copy of orders be filed under Decimal File 300.4, Folder 300.
