1. The attached (incomplete) Initial Roster, 61st QMS Co, Camp DelGado, undated signed by Oscar L. Ledesma, 3d Lt, QMS-Res, Commanding and James E. Bickerton, 1st Lt, 26th Cav (PS) Acceptance Officer, was received as evidence in the case of Federico C. Cadion.

2. Of twenty-two (22) names listed on the Initial Roster, twenty-one (21) files were located. A cursory examination of the twenty-one files show, compatibility of date and place of induction, organization, commanding officer and date of disbandment.

Majority of files contain a true copy of an (extract) of SO#163, Hqs, 6th MD, dated 28 Oct 41 calling the individual to active duty effective 16 Nov 41, with assignment to 61st QMS Co, 61st Div (PA). A true copy (extract) of SO#163, in the file of Agustin Laurista is signed by C. H. Brewer, 2d Lt, AGD, Cert. Off. Liv ~~Sec. Sec~~ also one signed by R. V. Chambers, 1st Lt, AGD, Asst. Adj. Gen.

3. A search of USAFFE-PA archives on file in Records Branch, RPR Div. (S.O., Rosters, Payrolls, etc.) fails to reveal any record for the 61st QMS Co. However; the history of 61st Div (PA), Folder #11, Historical file, contains a reference that the 61st QMS Co was mobilized on 17 Nov 41 at Iloilo.

4. Guerrilla archives of the 6th MD, indicate the following individuals; Federico Cadion, Daristo Castillion, Mauro Labro, Elpido Magno, Andres Perocha and Gregorio Semora had prior service with the USAFFE, enlisted in 1941.

5. The signatures of Oscar L. Ledesma, 3d Lt, QMS-Res, Commanding and James E. Bickerton, 1st Lt, 26th Cav (PS) Acceptance Officer, appear compatible with signatures found in respective 201 file.

6. Submitted roster is incomplete, typed carbon copy in two different colors.
