1. This project initiated to verify the authenticity of Par 3, SO#151, Philippine Army Headquarters, Fourth Military District, dated 18 August 1941, submitted in the case of Glicerio H. Calupig (original mimeographed extract copy returned to NOK) pertaining to assignment. (Original documents were examined for additions, deletions or signs of alterations; none noticed, with exception of the addition of addresses).

2. Eighty-seven (87) names listed under Par 3, SO#151 are also found listed under Par 8, SO#176, Army Headquarters, Manila, dated 3 August 1941, on file in Records Branch. Discrepancy in the spelling or nine names noted.

3. Historical reference file of the 41st Division on file in Records Branch shows officers and keymen were inducted into the USAFFE on 1 September 1941. This is supported by GO#6, Hqs, United States Army Forces in the Far East, Manila, Philippines dated 19 August 1941, (in part): Cadres of the 43d Inf consisting of all officers and sergeants, clerks and cooks are called into the service of the Armed Forces of the United States effective 12:01 a.m., 1 September 1941.

Component units of the 43d Inf were mobilized on 24 November 1941, at Calapan, Mindoro.

Some individuals listed on order in question are also mentioned in the history of the 43d Inf, source of which is unknown, presumably compiled by AGRD.

4. SUMMARY:

Order under study was issued by the Fourth Military District (PA) assigning the individuals listed therein to various component units of the 43d Infantry. Inasmuch as we have on file in Records Branch, SO#176, issued by Army Headquarters, Manila (PA), dated 3 August 1941, calling the same individuals to active duty effective 28 August 1941, with assignment to the 43d Infantry (no component units of the 43d Infantry shown) no 201 files were drawn. Historical information of the 43d Infantry, lists some of the individuals shown on order in question.

5. Recommendation:

Recommend that Par 3, SO#151, Philippine Army Headquarters, Fourth Military District, Department of National Defense, Commonwealth of the Philippines, dated 18 August 1941, be accepted as an authentic archive of a Philippine Army unit prior to mobilization into the USAFFE (order will supplement SO#176 by showing component unit assignments). Further recommend that order be carded, cards placed in Master Card File; a copy of order be filed under Decimal File Number 300.4, Folder ³³⁵ and Memo USARCEN Form 546 be placed in each 201 file.
