1. This project initiated to verify authenticity of par 3, SO #146, HQ 7th Mil Dist, DND, Commonwealth of the Philippines, dated 11 Oct 41. This extract copy of SO #146, submitted in the case of Emiliano E. Emperado (original mimeographed extract copy returned to NOK), contains the names of 187 PA personnel called to active duty effective date of orders, as replacements for assignments with units of the 71st Infantry Regiment.

2. A search of 201 files for 40 of the names listed resulted in the location of 31 files pertaining to individuals shown on orders. Nineteen of these files contain information indicating the individual died prior to return to military control. Twenty files contain positive USAFFE determinations, 19 of which are supported by USAFFE archives (O'Donnell POW, Capas Death Records, etc.).

3. Except for alleged date of call to active duty or induction, approximately 75% of the files examined are consistent with SO #146 regarding home address, rank and organization. With regards to discrepancies in alleged date of call to active duty or induction, some allowance should be made since the orders show the individuals were called to active duty effective the same date the orders were issued, plus the fact that in many cases, the information was furnished by the next of kin.

4. Historical Reference File for the 71st Division (PA) shows that the 71st Infantry Regiment (PA) was inducted into USAFFE on 1 Sep 41. Presumably the reservists listed on SO #146 were called to active duty as replacements for individuals who were called to active duty and failed to report, or if they did report were rejected for physical or other reasons. Affidavit of Newton E. Serion, dated 21 Apr 47 (copy attached), submitted in the case of Simeon E. Emperado contains information relative to call to active duty and induction pursuant to special orders involved. (Both are listed on SO #146 and have positive USAFFE determinations in their files.)

5. A comparison of par 3, SO #146 with SO #144, HQ 7th Mil Dist dated 7 Oct 41 shows they are compatible regarding organization title, command line and signature, and indicates consistency in numerical sequence.

6. Recommend that par 3, SO #146 be accepted as an authentic Philippine Army archive, that orders be indexed, cards filed in Master Card File, and copy of orders be filed under Decimal File 300.4, Folder 19.

I, NEWTON E. SERION, O-74156, 2nd Lt., Inf., PA, a former USAFFE soldier, and a commissioned officer of the "I" Co., 3rd Bn., 31st Inf., Regt., Manila Military District, PA (Folson's Fil-American Guerrillas); honorably discharged on 14 February, 1946, at Camp Balara Deprocessing Center, Quezon City, and presently residing at Vallehermoso, Negros Oriental, Philippines, after having been duly sworn to in accordance with law, hereby depose and say:

(a) That I personally knew one Pvt. SIMEON EMPERADO, who was a native of the municipality of Ayuñgon, Negros Oriental.

(b) That as secondary school graduates of the Class of 1941, (he graduated from Neg.Or.TRADE school), we had undergone the summer-cadre-training course and then graduated as reserves from the 1st Negros Oriental Cadre, Guihuñgan, Negros Oriental.

(c) That sometime on 31 October '41, when we were called to active military duty, I saw him and we were again together at Camp Fabrica, Negros Occidental, as replacements for the 71st Inf.Regt., 71st Division, USAFFE-PA. At this time then this regiment was already cantoned at Camp O'donnell, Capas, Tarlac.

(d) That on 1 November '41, Pvt. SIMEON EMPERADO, I, and all others in this group of replacements for said regiment, were inducted into the USAFFE by Capt. HOWARD PAHL, USA, an American Officer, who came from 7th M. D. Hqs., Binalbagan, Negros Occidental (Camp Araneta).

(e) That after the issuance of clothings and equipments at Camp Fabrica, we were shipped to Camp O'donnell on or about 15 November '41 and arrived thereat on or about 17 November '41. Majority of the replacements including Pvt. S. EMPERADO and I were assigned to the Combat Co., of the 71st Infantry Regiment. This company was commanded by Lt. LEONCIO GINSON, Inf.-PA.

(f) That a day after the outbreak of the Pacific War, this regiment was deployed along the Lingayen Gulf Area. Said regiment was commanded by Lt. Col. BONNET, USA.

(g) That after the various engagements against the enemy in the different Pangasinan towns, our outfit moved down to the western coast of the Bataan Peninsula. Our last assignment was on the beach defense of Saysayin point, approximately 6 miles south from the town proper of Bagac.

(h) That our company was last paid to include 31st January '42. Pvt. SIMEON EMPERADO was not on AWOL or a deserter of his unit. I knew all these facts, because he was one of the enlisted men under me.

(i) That upon the fall of Bataan, we were first concentrated near the town of Bagac. Sometime on April 20, 1942, I lost sight of Pvt. SIMEON EMPERADO, who was also with the death march because he went ahead with other comrades, while I slowed down my marching, for I was already weak and could no longer walk fast due to exhaustion.
