1. Since my departure is imminent I think it best to place in writing my reasons for desiring the return of Lt. Wortman to the Philippines in connection with the Blue Eagle investigation.

2. In the study prepared by Major Coates, the only person not a member of the Blue Eagle Brigade who has either stated or recommended in writing that the Blue Eagle Brigade should be recognized is Lt. Wortman. If he should now say that his investigation was incomplete or was casually made or that it was directed by someone else higher up in the chain of command there would be a 100% concurrence for the revocation of the recognition already announced. Any information which can be obtained from Lt. Wortman concerning the implication of personnel of the Guerrilla Affairs Division in skulduggery concerning the Blue Eagle unit will be incidental as well as any data concerning the recognition of other units that we consider cloudy. I consider Lt. Wortman to be a fertile source of information concerning the operation of the Guerrilla Affairs prior to the turn over to AFWESPAC on 5 November 45. However, the primary reason for his recall is as stated in the first two sentences of ~~above~~ *this paragraph.*

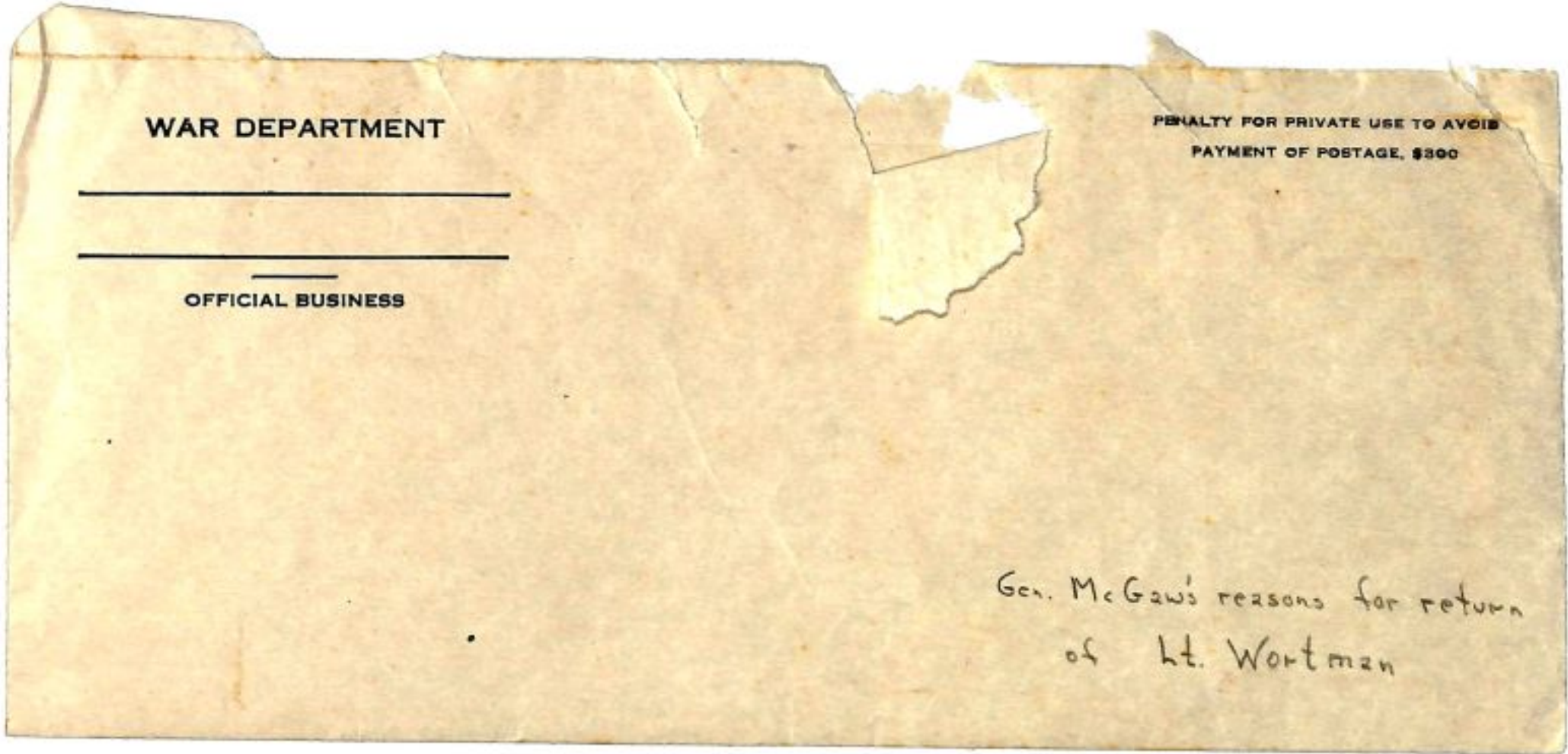
