1. Transmitted herewith is a tabulation of 397 names representing claims which were stopped and investigated during the period of 1 Jan and 31 July 1948, which the undersigned was OIC, Authentication Group.

2. The files are secured in the present Files Control Section and carded, each card containing a descriptive statement as to what is wrong with each case and just how it was determined to be denied for payment, i.e. forgery, tampering, false Form 23 or in many instances, a true copy of the original processing obtained from Records Depot, HNDF, with respect to sickness and hiding.

3. The amount involved is upwards of \$2,000,000.00, which should not be confused with the separate statistics kept in the office of Chief, PA Branch. This figure represents money that would have been paid had the claim been signed in the Authentication Group, whereas, the figure kept by chief of the PA Branch represents money already allotted which will eventually be credited to the account of the United States Government.

4. Certain cases now held on the basis of derogatory CIC information should be turned over to the investigation branch and a more detailed report furnished and each case definitely identified as that on which the CIC has such derogatory information. (These cases are logged separately and are in the safe of the old Authentication building).

5. Attention is invited to the footnotes on the tabulation of these claims wherein the cases were determined as fraudulent, but paid due to the lapse of time between the first adjudication and the redetermination. In some instances, the difference between pay grades was saved, even though the bulk of the claim had already been paid under false pretense.

6. Lt Clark will be fully oriented prior to the separation of the undersigned regarding these cases.
