





In compliance with Ltr HPA, subject: "Disbanded Units, Deserters, Etc.", dated 8 May 1945, a thorough investigation on each particular case of subject individuals covered by said letter were made and a search on the whereabouts of the officers and enlisted men who belonged to their previous units was conducted.

2. 1. The determination as to whether or not an individual inducted into the USAFFE falls under Letter HPA 1 September 45, does not necessarily depend on the period of time from induction to disbandment.

2. As far as this Section is concerned, said letter refers to personnel who, at the outbreak of the war, voluntarily presented for service and were inducted into the USAFFE but later, had to be disbanded either at the instant of the immediate superior who accepted them due to enemy pressure or upon instructions from HPA. Those who were in active service already when they presented & were inducted are not, therefore, included. Likewise, those who presented in response to written orders in which they were named and assigned to units and were inducted into the USAFFE but, for reasons independent of their own, were disbanded or dispersed, are not also included. It should be stated here, that at that time orders calling reservists to active duty include assignment to units of reservists so called.

NOTES ON DEMOBILIZATION

1. Base M - San Fernando, Ia Union and ASP No. 5 at San Jose, N. E. both refuses to accept our organizational equipment for the reason that both are closing in the near future.
2. Present Arrangements for turn-over of equipment and supplies are being made with Base "X".
3. In the meantime, suggest that all our equipment and supplies be turned over to HPA units or sections and/or to Camp Ord, 2nd Replacement Supply Officer, for the following reasons:
 - (1) The transactions would be easily expedited, considering the distance and availability of transportation, as 4th Camp Complement (PA) at Camp Ord can have us use the 13th QM trucks.
 - (2) These supplies and equipment will be hard to get when units of the Regular (Peace-time) Army will be activated, as typewriters, mimeograph machines, tables and other items considered "critical" ever since. The refers in particular to the Military District Headquarters to be organized in the near future, unless there is assurance from the U. S. Army that supplies & equipment are reserved for these proposed units.
4. ~~NO~~ RPD team has so far ~~not~~ reported to date. It is necessary for settling claims of personnel to be demobilized, as required in Cir. 182.
5. In expediting the process of demobilization, it will depend on:
 - a. Decision & procedure of U.S.A. Dept to accept receipt of turn-over supplies and equipment.
 - b. Availability of transportation.
 - c. Availability and speed in the taking of X-Ray and Serological examination of personnel.

1. Redito, Pablo - Sgt.
Co. "C" 21st. Inf. - CO, Lt. Juan Jimenez.

a. Get separated from unit 26 Dec. at Carmen, Pangasinan. While on firing line, he suddenly found out that he was left behind, together with 2 men of his unit, Cpl. Aniceto Damag and Cpl. Martinez. He proceeded to rejoin his unit. Heard that 3d Lt. Geronimo Bongbongan, his Platoon Leader was at San Manuel. The three of them located Lt. Bongbonga, and in attempt to rejoin unit, whose location they did not know at that time, went to Guyapo, then to Camp Malatiki, Tarlac, then to Mangataram, then to Bugallon where they heard rumors that their Regimental CP was located. Not finding anybody there, they proceeded to Zambales, with a group of men who were also cut off. He arrived at Sta. Cruz, where he met a certain Lt. Cinzon. Here they stayed until the fall of Bataan, when a certain Lt. Aviles came, who took their arms and disbanded them. Unit with CO reached Bataan.

2. Paliset, Pastor - Corporal
Anti Sabotage Regt. - Lt. Itahim.

a. Was guarding Endendencia Bldg. at Manila when Japs arrived. Disarmed by Japs and set free. Then reported to Singalong, where Col. Buenconsejo ordered them to disguised as Metropolitan Policemen. Was assigned as Policemen in Herran, then left duty to go to Bataan. Reached as far as Macabebe, where Japs made him worked. escaped to Sn. Fernando and reached Sta. Cruz by way of Sta. Ignacia and Mangataram. This was about end of January. Were supposed to have been organized guerilla under Lt Antonio Garcia, and Lt. Cerigon, Could not go to Bataan by way of Olongapo. So stayed in Sta. Cruz until he got sick and had to be sent home. Stayed inactive since then until return to Military Control.

3. Taguines, Jose - Corporal
"E" Co. 23d. Inf.

a. Separated Jan. 2, 1942 at baman. During an engagement of Japs, they were not advised of any withdrawal, because runners sent by CO - Lt. Sibayan, did not reach them. They kept on fighting until machine gunner was killed. Then, they found out that their companions had left. Took off uniforms after observing nothing happened to civilians. Reached as far as Forac, Pam-panga in attempt to join unit, but could not penetrate lines. So, went home. Remained inactive during Jap Regime.

4. Rendon, Alepio - Cpl.
Bul. Co. P.C.

a. Was guarding Radio Station at Polo, Bulacan until Dec. 31 when the station was demolished and American who demolished it told him and his companion, Pvt. Pedro Lopez to report back to Station at Malolos; but when arrived at Malolos, company had left. Attempted to go to Bataan, but reached Calumpit only. Later conversation with company clerk, Sgt. Clifompo Isidro, now at HPA reveals that the 2 guards at Radio Station were entirely forgotten when their company moved out. Engaged in farming during Japs Regime.

5. Cruz, Gabriel - Pfc.
Former unit- Co. "I" 21st. Inf.

a. Missing in action at Moron.
Got left with 9 men, among whom were Corporal Pablo Zamora, with whom he escaped, and who later died - and Lt. Leoncio Cristobal, whose whereabouts he doesn't know ever since they got separated.

6. Diaz, Maritn- Pfc.
From unit Co. "H" 21st. Inf.

a. During a fire fight in Porac, Platoon Leader got killed (Lt. Melecio de Guzman) and they attached themselves (with Pfc Genaro Gonzales, now in Olivas, and Corporal Roselio, both of Co. "H") to platoon of Lt. Flores of C. "F" 21st. Infantry (now in Olivas) They got short of ammunition and found out they were cut off. They destroyed their arms, and tried to pass through Japs lines. Not succeeding, he, with Lt. Flores and Cpl. Toselio went toward Mabalacat where they stayed a week. Not having a chance to slip through Bataa, they went home.

7. Fronda, Julio- Pvt.
Attached to _____ Company, 21st. Infantry


1. Request that disciplinary action be imposed to Cpl. Avelino Mendoza for the following reasons:

(c) That such an act was an outrageous disobedience to orders was done knowingly and voluntarily after having been reminded and warned in the morning of the commitment.

(d) To cut short such unauthorized treatments thereby ensuring a more efficient service which if left neglected and overlooked will not only endanger himself of repeating the same mistake but also endanger the health of the command and to minimize the undue and unofficial unauthorized disposition and discretion of drugs to impose better order behaviour and discipline on the subject corpsman, I therefore request disciplinary action be taken on the said Cpl. AVELINO MENDOZA.






