The technique of a business letter.

The technical arrangement of a business letter consists of the following arrangement parts:-----

The heading consists of the address of the persons firm or department printed on the right hand top corner of the first page.

The date is written just under the heading, preceded usually by the name of the city or town on the same line?

The instruction includes the name and address of the person or firm to whom the letter is written. It is, however, desirable that it should be kept on not more than three lines. The name of the addressees occupies the first, the house number and street, the second, and the city and province, the third. But if consideration is to be paid to the position and or official capacity of the individual or the status of the firm, and such is always necessary a fourth line may be added. or the house number and street replaced.

The salutation is the phrase with which the letter commences custom has adopted the form of " Dear Sir, " " and " " Gentlemen: " as most convenient, It should be inserted immediately below the introduction and be followed by a colon and dash.

The body is the part dealing with the subject matter of the communication. It should commence immediately below the salutation, a little to the right.

The complimentary close is the formal ending of the letter. The form chosen depends upon that adopted for the salutation, but in business letter " Yours faithfully, " " Yours truly, " " Very truly" "or" Yours respectfully,, " is used.

The signature is the last but the most important of all. in business letters are always signed by some one with power of attorney.

The technical arrangement of a business letter can be best illustrated by the following example:----




