MEDICAL DEPARTMENT  
SPECIAL ORDERS NO. 5:

1. The intravenous use of "solutions" of atabrine dihydrochloride prepared by dissolving tablets of atabrine dihydrochloride, 100 mgm. (Medical Supply Items 10845 and 10846) in water or any other solvent is hereby prohibited.

2. Solutions of atabrine dihydrochloride prepared by dissolving specially prepared sterile atabrine dihydrochloride in ampules containing 200 mgm., in double or triple distilled water, is authorized when, in the opinion of the attending surgeon, the urgency of the case outweighs considerations of the possible toxic effect.

3. In cases for which intravenous injection of atabrine dihydrochloride is employed, the amount of the drug given at one time will not exceed 100 mgm., to be given diluted with at least 7 cc of sterile double or triple distilled water.

4. The parenteral (intravenous or intramuscular) administration of antimalarial drugs in uncomplicated cases of malaria will be discouraged by all Medical Officers. The unwarranted custom of administering antimalarial drugs by injection routinely conveys the erroneous impression to military and civilian personnel that these drugs are not sufficiently effective when given orally.

5. The desirability of prophylactic use of atabrine and quinine especially for key personnel on active missions will be stressed by all medical officers, to aid in the maintenance of fullest efficiency.

6. Surgeons of Divisions and Higher echelons will be directly responsible for the dissemination and enforcement of this order, among medical officers of lower units.
