

II. MOST OF THE EARLY CHURCH FATHERS CLEARLY DISTINGUISHED BETWEEN THE INSPIRED SCRIPTURE AND THE APOCRYPHA BOOKS. Kieth I. Brooks states, "There is a great difference in the claims and in the style of the Biblical writings and those of the Apocrypha. There is much in the latter that is fantastic and contradictory to the Inspired Writings of Scripture."

A. THE ATTITUDE OF THE EASTERN CHURCH IN THE EARLY YEARS.

1. The Apocrypha was not recognized by the following men of the Eastern Church.
 - (a) Melito, who lived about 170 A. D.
 - (b) Justyn Martyr, 164 A. D. and Origen, 254 A. D.
2. The Council of Laodicea (363 A. D.) excluded the Apocryphal books and recognized our 39 books only.
3. The Patriarch of the Eastern Church, Metrophanes, who died 1640 A. D. did not recognize them. This date has force because it is after the Council of Trent.
4. The larger catechism 1839, the most authoritative doctrinal standard of the Greek Russian Church, expressly omits these books on the ground that "they do not exist in the Hebrew Original".

B. THE ATTITUDE OF THE WESTERN CHURCH.

The early Church Fathers held strictly to the Hebrew Canon of 39 books. Following are some of them who held firmly that the Apocryphal books were not inspired.

1. Tertullian, Bishop of Carthage, North Africa. (150-220 A. D.)
2. Hilary of Poitiers, France. (305-336 A. D.)
3. Ruffinus of Italy. (Died 410 A. D.)
4. Jerome, Scholar and Translator (340-420 A. D.). Jerome repeatedly insisted on the 39 books as canonical and emphatically drew the line between these inspired books and the Apocrypha. Gigot, the Roman Catholic authority on Biblical Introduction admits this by saying, "Time and again this illustrious doctor (Jerome) of the Latin Church rejects the authority of the deutro-canonical books (Apocryphal) in the most explicit manner."
5. Augustine limited the word "canonical" in the strict sense to the Hebrew Canon

PRISONER'S VERSION OF HIS CASE

This inmate was convicted of Murder by the Court of First Instance of Davao, alleged being responsible for the death of Japanese Wariko, in Zamboang, Davao City, on or about August 4th, 1959. He fought his case in the Court aided by a counsel but lost it. He insists that he is innocent of the charges, offering as an alibi that he was in elito Sisonan, Davao City, for the purpose of collecting a debt. He says that when he was arrested by the Constabulary, he was brought to the Secret Service Division and was chastised by the policeman. When he could no longer bear the punishment-punches on the stomach, he was forced to tell a lie by telling he killed the woman when in fact he did not, and his statements were taken in writing and then signed by putting his thumb mark on the affidavit.

Upon receipt of the report of the prisoner, the Bureau of Prisons, Manila, advised the Bureau of Prisons, Davao, to take the necessary steps to ensure the safety of the prisoner.
