2. All prices of same will be controlled by the Municipal Price Control Board, set up in all municipalities.
3. Selling of merchandise, food, etc. in secret places other than in public markets is strictly prohibited and declared illegal. Any merchant who fails or refuses to put his goods on sale in public markets or attempts to smuggle merchandise out of the 111th Provisional Battalion Area, will be imprisoned and subject to Military Law.
4. After a certain fixed date, all goods, commodities and foodstuffs that are now hoarded in some dwelling places, warehouses, and in the mountains, with the consent of the owner must be carefully searched by any authorized person by this Headquarters, and all merchandise seized or confiscated must be properly inventoried and sold to the General-Public at the prices fixed by the Municipal Price Control Board.
5. For security, the United States Forces in the Philippines now operating in the Islands, guarantees absolute protection to all merchants and their merchandise while they are engaged in business.
