MEMORANDUM

To: All Concerned

1. Effective 0001, 23 May 1945 no civilians will ride in government trucks without specific authorization from the G-5, this Headquarters. When trucks are dispatched to pick up laborers it will be so stated on the driver's trip ticket. Under no circumstances will government trucks pick up civilian hitchhikers.

2. No more than two persons (including the driver) will ride on the front seat of any truck.

3. No passenger will ride on any other part of a truck other than in the rear of the truck. There will be no hanging on to the sides, standing on running boards or riding on the bumpers.

4. No more than five persons (including driver) will ride in a 1/4 ton Jeep except in a tactical emergency. No more than ~~five~~ six (6) persons (including driver will ride in passenger cars, being used by this organization.


5. The CO, QM Bn will see to it that one copy of this order is furnished each driver and is carried in the vehicle at all times.

6. The Military Police Battalion will strictly enforce the provisions of this memorandum.


