Subject: Recommendation for Honorable Discharge

To : CO, USAFIP, NL

1. The following named enlisted men are hereby recommended for honorable discharge from the service for physical disability presumably contracted in line of duty:

- a. (1) Name- Leon Anod
(2) Rank & Organization- Sergeant, Co "A", 1st Bn
(3) Date of enlistment- July 9, 1942
(4) Physical disability- Ankylosis of right knee joint; ankylosis of middle finger right hand. The injury was incurred after entry into the service and in line of duty.
- b. (1) Name- Carlos Dumasi
(2) Rank & Organization- private, Co. "A", 1st Bn
(3) Date of enlistment- July 1944
(4) Physical disability- The ankylosis of the right knee joint was incurred after entry into the service and in line of duty.
- c. (1) Name- Mariano Dilla
(2) Rank & Organization- Pfc., Co. "B", 1st Bn
(3) Date of enlistment- October 8, 1942
(4) Physical disability- Cataract of left eye. Pterigium on same eye. A whitish membrane surrounding the iris of left eye. The injury was incurred after entry into the service. The injury was contracted in line of duty.
- d. (1) Name- Mariano Langwas
(2) Rank & Organization- private, Co. "G", 1st Bn,
(3) Date of enlistment- Nov. 15, 1943
(4) Physical disability- Intense headache, fever, and dizziness ofentimes as a result of a gunshot wound he received when in Bataan. poor vision.
- e. (1) Name- Emilio Rivas
(2) Rank & Organization- pfc., "C" Co., 1st Bn
(3) Date of enlistment- October 1, 1942
(4) Physical disability- (See Dr. D. R. Narvaez certificate dated Sept. 10, 1944, attached with S/R.)

- g. (1) Name- Molintas Sahgy
 (2) Rank & Organization- Private, Co. "C", 1st Bn
 (3) Date of enlistment- November 1942, 14th Inf
 (4) Physical disability- Chronic Appendicitis. Pains in both lumbar regions; impairment of hearing of both ear. The pain in the lumbar regions and impairment of hearing of both ears begun after entry into the service and in line of duty. These were due to the maltreatment he received from the Japs last April, 1943 when he was NA Leader in San Pascual, Tuba and at the same time a member of the 14th Inf.

2. Recommend that the above named enlisted men may be entitled physical disability compensation which will be determined by the degree of disability besides bonus, pay and allowances due or to become due.

3. Sergeant Bernard Sagoc, Co. "B", 1st Bn, enlisted on February 12, 1944, having been found physically unfit presumably not contracted in line of duty is also recommended for honorable discharge. He will be entitled for bonus, pay and allowances due or that may become due.

4. The immediate discharge from the service of the above named EM is strongly recommended for the good of the service. They will be replaced by qualified applicants who will be of greater help in the organization. The bonus, pay and allowances may be paid to them after the war. They are all natives of Benguet and they can be taken cared of by their families and relatives in the meantime.


