1. Request that 2nd Lts. Bienvenido Azurin and Conrado Nebriaga be immediately apprehended and turned over to this Headquarters.

2. Lt. Azurin left his station without permission of his Commanding Officer on 31 July 1945. According to information he went to Vigan to see his family.

3. Lt. Nebriaga left the Bn Aid Station for the Clearing Station at Cervantes about ten (10) days ago. Without knowledge of the Bn Surgeon or his Commanding Officer he went down to Tagudin or Bacnotan his hometown. According to Capt. Valdes of the Clearing Station at Cervantes, he never passed nor was admitted at the Clearing Station.


