General Order
No. 6

M-DAY AND M PLUS DAY MISSIONS

GENERAL MISSION:

1. To destroy enemy lines of communications; i.e. roads, bridges, telephone and telegraph lines.
2. To harass, delay, if possible, destroy all enemy troops and supply movements.
3. To destroy enemy supply dumps, truck parks, troop concentrations and command posts.
4. To prevent the enemy from securing locally food supplies, materials (bridge and road, etc.) labor, means of transportation (i.e. cargadors, horses, carts, trucks, etc.).
5. To reconnoiter all trails leading into the Gagayan Valley within the respective Bn. sectors with view of preventing enemy from using same and as avenue of approach to the Gagayan Valley.
6. To be ready to carry out the above missions by November 15, 1944 (i.e. reconnaissance, plans, formulated orders, detailed instructions, training, assembled materials, supply details, etc. must be completed by 15th November, 1944.

FIRST PHASE: (To be carried out on orders)

A. 1st Battalion:

Task 1. Bontoc - Bagabag Road

- a. Destroy one bridge (Lanut) and block road in two or more places (Payawan) and between Kiangan and Bolog), between Bagabag and Banaue, and leave detachment in vicinity of Lanut with mission of:
 - (1) Harassing enemy's attempt to open road.
 - (2) To harass enemy troop movements.
 - (3) Report any info to higher Hq.
- bb. Destroy one bridge (Ibulao) and block road in two or more places (cliff at Ibulao) and Hucab, between Kiangan and Lanut.
- c. Block road in two more places between Banaue and Talubin and destroy ridge in the vicinity of Talubin and leave detachment in the vicinity of Talubin with mission of (same as 1. a. above)

Task 2. Bontoc - Sabangan Road

- a. Destroy small bridges and tunnels.

Task 3. Be prepared to take over from Fifth District the following: Destroy and block road in three places between Bagabag and Santiago and leave the road a strong detachment with mission of same as 1. a. above



B. 3rd Battalion:

Task 1. Bontoc - Enrile road

- a. Block or destroy road in two or more places between Bontoc and Lubuagan.
- b. Block or destroy road in two or more places between Lubuagan and Enrile; and destroy the ferry in vicinity of Calanan, leaving a detachment in the vicinity of Calanan (Lubuagan-Tuao-Enrile road junction) with mission of:
 - (1) Harassing enemy's attempt of open road.
 - (2) To harass enemy troop movements.
 - (3) Report any info to higher Hq.

SECOND PHASE:

1. To harass and delay enemy movements throughout bn. sectors and report to this Hq. all enemy movements and action taken that is being taken against this movement.
2. To attack and destroy such objectives as ordered by Hq. USAFIP, NL or District Hq. (See Gen. Mission)

GENERAL INSTRUCTIONS

1. In first phase, in areas where it is impossible or inadvisable to destroy bridges or roads, the following methods may be employed:
 - a. Fall large trees at close intervals along a kilometer or more of the road.
 - b. Cause slides by blasting at deep cuts. Where this is done details must be available to harass the enemy in the event they attempt to clear road. These methods should not be looked upon as desirable where it is possible to either destroy a bridge or the road bed.
2. Avoid dissipating your commands in small groups. In so far as the situation and missions permit, keep units intact and together.
3. All Companies and Bns. must be prepared to move with one week's ration on call. They should have definite and workable plans to continue to supply their units on extended missions.
4. Enemy information, in as much detail as possible, must continually be forwarded from lower units to the next higher units. Co. and Bn. Hq. that this information passes thru, will, in the absence of special orders, initiate appropriate action, notifying the next higher Hq. of the action taken.
5. The name, rank, and organization of the officer immediately in charge of the tasks listed herein under FIRST PHASE, will be submitted to this Hq. or before November 15, 1944. Thereafter any change in assignment of the task will be submitted without delay.

1. In compliance with instructions, letter S-Staff Care for Enemy Documents, Hq. 1172(G-2), dated 21 October, 1944, Battalion Commanders are hereby ordered to exert efforts to ambush Japanese Army Staff care within their respective sectors for the purpose of capturing enemy documents.

2. Information has been received to the effect that staff care of the Japanese Army bear the following distinguishing flags:
a. Corporal and colonels yellow flag.
b. Lt. Colonels and Majors Blue flag
c. Captains and Lieutenants Red Flag
Care bearing red flags with horizontal stripes are reporters or correspondents only.

3. Previous letters re enemy documents, papers, prisoners, etc., from this Hq. and higher Hq. will be referred to, and complied with.

4. Any and all documents, papers, etc. intended for higher Hq. will pass through this Headquarters.

GENERAL ORDERS

NO.....8

1. In compliance with instructions, Ltr., S-Watcher Stations, Hq 1122 (G-2), dated 20 October, 1944, Battalion Commanders are hereby ordered to establish without delay the following watcher stations within their sector:

A. ROAD WATCHER STATIONS:

a. Duties: To observe, record and report all enemy movements day and night, along the assigned roads. Reports will be made in the form attached hereto.

b. Road station (watcher) will be established by the BN CO's within their respective sectors as follows:

- (1). 1st Bn. 11th Inf. P.A. Sector
 - (a) Between Bontoc and Bagabag on Highway No. 4.
 - (b) Between Bontoc and Sabangan on Highway No. 11.
- (2). 3rd Bn. 11th Inf. P.A. Sector.
 - (a) Between Bontoc and Lubuagan on Highway No. 11.
 - (b) Between Enrile and Pasalangao Bridge on that road.
 - (c) Between Tuao and Pasalangao Bridge on that road if and when completed.
 - (d) Between Balbalasang and junction of Lubuagan-Tabuk on that road when and if completed.
- (3) 1st Bn. 12th Inf. P.A. Sector
 - (a) Between Calamaningan and Gonzaga on that road if and when completed.
 - (b) Between Gonzaga and San Vicente on that road if and when completed.
 - (c) Between Calamaningan and Galsingon on Highway No. 5.
 - (d) Between Fairs and Piat on that road if and when completed.
 - (e) Between Alcala and Gonzaga if report of road between those points is correct.
 - (f) Between Alcala and Taguegarao on Highway No. 5.
 - (g) Between RJ to Tuao to Enrile on Taguegarao Piat Rd

c. Reports will be picked up daily from stations from the 1st Bn 12th Inf. P.A. and forwarded to this Hq without delay. Reports will be picked up weekly from stations of the 1st Bn and 3rd Bn 11th Inf. P.A. and will be forwarded to this Hq without delay.

B. AIRFIELD WATCHER STATIONS

a. Duties: To observe and report all arrivals and departures of planes, day and night, at their assigned airfields and the effects of all Allied air attacks on the field.

b. Reports will be picked up daily from these stations and forwarded to this Hq. without delay. Report the effect of ~~attacks~~ air attack will be sent to this Hq RUSH. (No RUSH report will be made of mere facts of bombing.) If a radio station is within one hour hike from the airfield watcher station, hourly reports plus RUSH report on the arrival or departure of more than three (3) planes will be sent to the



radio station for transmittal to higher Hq. If the radio station is at, or in the vicinity of the airfield watcher station, the arrival or departure of all planes will be reported immediately to higher Hq.

c. Reports will be made in the form attached hereto.

d. Bn Commanders will establish airfields watcher stations in the vicinity of all airfields in their areas in use by the enemy.

C. NAVAL WATCHER STATIONS:

a. Duties: To observe, record and report all enemy water craft arrival, at, departing from, or passing by their assigned stations, and the effects of Allied air attacks on the ports assigned.

b. Reports will be made in the form attached hereto.

c. Reports will be picked up daily from all these stations and forwarded to this Hq. without delay. Reports on the effects of bombings will be sent RUSH to this Hq. If and when a radio station is within one hour hike from the watcher station, all arrivals, departures of ships passing by will be reported as soon as ascertained.

d. Battalion Commanders will establish naval stations (watcher) at all ports within their areas at such additional points along seacoast as will make adjoining naval watcher stations not more than fifty (50) kilometer apart. The CO, 1st Bn. 12th Inf. will establish a naval watcher stations on the Cagayan River between Tuguegarao and Alcala, and between Alcala and Aparri.

D. AIRPLANE WATCHER STATION:

a. Duties: To observe, record and report all planes passing in the vicinity of their stations and to observe the point of crash of airplanes shot down or forced down.

b. Reports will be made in the form attached hereto.

c. Reports will be picked up weekly from these stations and forwarded to this Hq without delay. Reports regarding planes shot down or forced down will be forwarded to the nearest unit Hq RUSH in the scene of the crash. When and if radio equipment becomes available reports will be forwarded direct to higher Hq thru the nearest radio station. If the radio station is in the vicinity of the watcher station all planes observed will be reported immediately.

d. Battalion Commanders will establish such airplane watcher stations as are necessary to observe all planes passing over their areas.

2. Battalion Commanders will caution their sub-units leaders to be on the continuous watch in order to detect any large numbers of troops or quantities of equipment passing thru their sectors via trail or across country by such routes as would cause them to be missed by this Hq without delay.

3. Battalion Commanders are authorized to hire or pick up for induction such intelligent personnel as are necessary to man the above listed watcher stations that are necessary to set up in their sectors. Stations functions of the same or different types maybe combined in the same station where ever this maybe done without interfering with the individual missions assigned.

4. It is realized that the above is a pretty large order. However, it is essential if we are going to be able to furnish precise information in our areas. Human efforts be made to get those stations into existence and operation as soon as possible -----even if it is not possible at first to pick up reports as often as specified above. If this is done we will have our ground work all laid for the time if and when we get radio equipment.

GENERAL ORDER)
No. . . . 9)

1. In compliance with G.O. No. 18, U.S.A.F.I.P., N.L. dated 24 October, 1944, all troops will assemble into platoon or Company Camps. All officers and enlisted personnel will be on duty for twenty four (24) hours a day.

2. All personnel, except when engaged on missions, will undergo rigid training of not less than eight hours a day. Attack are weekly schedules that will be conformed to.

3. Battalion commanders will make such inspections and will cause such inspections by their staffs to insure the provisions of this order are carried out and will make necessary corrections in training procedure to insure that the highest state of efficiency is reached by all troops in the shortest possible time.

4. All Headquarters and troops' camps will establish and maintain rigid and efficient outpost systems. Personnel on guard and outpost duty will be inspected by an officer at frequent intervals to insure that men on duty are alert and not asleep on post. (In this connection frequent inspections will be made between retreat and midnight, and midnight and reveille as well as during day light hours.) After personnel have been properly instructed to their duties, harsh disciplinary measures will be taken against personnel found not to be alert on duty or sleeping on post. In addition to an outpost system every Headquarters and troop camps will prepare plans for local defense measures of their respective camps in case of enemy raid thereon. These defensive plans should be drawn with the view to ambushing and totally destroying small enemy patrols and with the view of inflicting severe losses on larger enemy patrols.
