2. Two other ex-servicemen, namely: Pvts. CORCHOD AGLAYEN, ex-trainee and JOHN TAYOG, ex-PS who were physically examined on 8 May and 1 May '45, respectively, also reported for duty with the above group, and became casualties on 21 May 1945. Pvt. CORCHOD AGLAYEN died of gun-shot wound while Pvt. JOHN TAYOG was found missing after the attack of Cervantes central, Ilocos Sur. These men might have died in line of duty without having been inducted into the service.

3. The above-named enlisted men reported for duty to the 1st Bn, 11th Infantry, PA, in respond to the call for ex-service men to report. As there were no available vacancies then, they were instructed to report to the "A" Co, Provisional Bn where they rendered service and participated in the attack of Bessang. On 22 June 1945, they were found out as excess (over-strength) of "A" Co and were then instructed to report to this company to fill up our vacancies.

4. According to these EM no Special Order covering their inductions and assignments to the "A" Co, Provisional Bn, has ever been received by them and presumably, the C. O. of "A" Co might not have submitted his recommendation for their inductions and assignments for the reason that there were no vacancies for them; yet, they were sent to the firing line.

5. For the sake of justice to them and if possible, it is earnestly requested that they be inducted and assigned to the "A" Co, Provisional Bn effective the dates of their physical examina-

tion at Barlig from where they started to the CP of the 1st Bn, 11th Inf, then direct to Cervantes. And if they are really excess of that company, it is recommended that they be transferred to this company effective 1 June 1945, or 24 June 1945, the date when they reported to this company.

6. As of today (26 June 1945) the actual strength of this Co is as follows:


