- a. Maximine Matias femmer BC in 6th Company stationed at Bambang. Deserted on October 7, 1944 upon receipt of the first warning. Joined "L" Company on 11 Oct 44. Deserted because he was forced to-join the BC. At the first opportunity, he deserted and joined "L" Co, 14th Inf. on 11 Oct 44 with a revolver Cal .32. Desired to serve his country.
- b. Rufine Camangian fermer BC in 6th Company stationed at Bambang. Deserted on October 6, 1944 upon receipt of the first warning. Jd "E" Company as attached on 7 October 44. Transferred to "L" Co 14th Inf. 1 Feb. 45. Deserted because he was forced to join the BC. In view of the desire to serve his country, he deserted at the first opportunity with 50 rds ammunitions Cal .30.
- c. Pedro Sensano former BC in 1st N.V. Company stationed at Bayembong. Deserted on 1 Oct 44 upon receipt of the first warning. Jd "L" Co, 14th Inf. 2 Oct 44. Deserted because he was forced to join the BC and in view of the desire to serve the country.
- d. Mariane Sensane fermer BC in 1st N. V. Company stationed at Bayembeng. Deserted on 1 Oct 44. (Called to RHQ.)
- e. Enrique Milla fermer BC in lat N. V. Company stationed at Bayembeng. Deserted on 1 Oct 44 upon receipt of the first warning. Deserted because he was forced to join BC and joined because of his desire to serve his country.
