- l. As per order from R.H.Q. dated September 18, 1944 re physical examination of Officers and FM I am submitting a report of my findings on Sgt. Leon Anod and Pvt. Carlos Dumasi of Co. "A" whom I found to be with Physical defects which incapacitate them to render military service.
  - 2. a. l. Leon Anod Sgt. Co. "A" 1st bn 43rd Inf. (PS)

2. Date of enlistment - July 9, 1942.

6. Pate of physical examination - October 21, 1944

4. Nature of disease or injury - Ankylosis of Right knee Joint; Ankylosis of middle finger right hand.

5. The injury was incurred after entry into the service and in line of duty. The ankylosis of the middle finger of the right hand was due to a bolo wound received last July 13, 1942 when he was on patrol duty with one companion in barrio Gusing, Naguilian, La Union. While patrolling they met a suspicious person armed with a 45 cal. revolver, hand grenade and a bolo. When this suspicious fellow was asked if he was a soldier and did not answer them he was disarmed of the revolver and grenade. But when Leon Anod was voiding his urine the suspicious took his bolo and hit Anod on the shoulder and while trying to hit again the abdomen Anod prevented him from doing by using his right hand which resulted in the wounding of said hand hence the ankylosis of right middle finger. The ankylosis of right knee joint was due to an abscess of the region above the right knee last July 16, 1942 which lasted for more than a year when he was still in Co. "A", 121st. Inf. Under Lt. Felicisimo Abobo.

B. 1. Carlos Dumasi - Pvt. Co. "A" 1st Bn. 43rd Inf. (PS)

2. Date of enlistment - July 1944

3. Date of physical examination - November 19, 1944

4. Nature of disease or injury - Ankylosis of right knee joint. Total blurring of vision of right eye for near (Jaegers test) and Distant (Snellens test visions.

5. The total blurring of right eye was incurred prior into entry into the service. It begun last 1937 when he was playing basketBall when particles of the dirtientered into his eye (right).

The ankylosis of the right knees joint was incurred after entry into the service and in line of duty. The injury occured last August 11, 1944 when he, Lt. Florencio Esteban and some companions were on their way from Taloy to Co. "A" HO Camp Kabadatan. Suspecting that the enemy were proceeding towards them they seek cover and upon doing so he slipped in prone position on a rough stone lacerating his right knee which has just healed but he is unable to flex his knee joints I believe it takes three or four months before he will be able to flex his knee joint. This will be hastaned through daily exercise of same.

1. As per order from R.H.O. rephysical examination of Officers and EM I am then submitting the results of my findings on Bernerd Sagoc and Mariano Dilla of Co. "B" 1st Bn 43rd Inf (PS) whom I found to be with physical defects which incapacitate them to render military service. Therefore they be recommended for discharge.

2. (a) 1. Bernard Sagoc - Sgt. Co. "B" 1st Bn 43rd Inf. (PS)

2. Date of enlistment - Frebruary 12, 1944.

3. Date of physical examination - September 21, 1944.

4. Nature of disease or injury - Cataract of both eyes.
A whitish membrance surrounding the Iris of both eyes.

5. The injury was incurred prior to the entry into the service. The present ailment was due to the maltreat-ment received from the Japanese last October 4, 1943 when he was the Mayor of Kapangan of which he was suspected to have been hiding in his area American Officers with 300 soldiers.

(b)1. Mariano Dilla - Pfc. Co. "B" 1st Bn 43rd Inf (PS)

2. Date of enlistment - October 8, 1942.

3. Date of physical examination - September 24, 1944.

- 4. Nature of disease or injury Cataract of left eye. Pterigium on same eye. A whitish membrane surrounding the Iris of left eye. His old age may be a contributing factor to the disease.
- The injury was incurred after entry into the service. The injury was contracted in line of duty. The present ailment begun last September 1943 when he was sent on a mission by Major Calvert to make a sketch of the Japanese Garrison in Bontoc. On his way from Bontoc to Baguio while riding on a Japanese truck a stick struck his left eye thus causing the above stated injury.

1. As per order from R.H.O. dated September 18, 1944 re physical examination of Officers and EM I am submitting a report of my findings on Pvt. Mariano Langwas and Pvt. Molintas Sahoy both of Co. "C", 1st Bn, 43rd Inf. (PS) whom I found to be with physical defects which incapacitate them to render military service.

2. a. l. Mariano Langwas - Pvt. Co. "C" 1st Bn, 43rd Inf. [PS]

2. Date of enlistment - 1943

3. Date of physical examination - November 13, 1944.

4. Nature of disease or injury - Intense headache, fever, and dizziness often time as a result of a gunshot wound

he received when in Bataan. Poor vision.

5. The headache, fever and dizziness are the effects of a gunshot wound incurred when he was in Bataan last March 1942. The injury was incurred prior into entry into the USAFIP. The bullet wound was located in the r right temporal region. The intense headache, fever and dizziness are well manifested when he walks fast and long distances. The injury has something to do with the poor vision.

b.l. Molintas Sahoy - Pvt. Co. "C" 1st Bn, 43rd Inf. (PS) 2. Date of enlistment - November 1942 - 14th Inf.

3. Date of physical examination - November 14, 1944.

4. Nature of disease or injury - Chronic Appendicitis: Pains in both Lumbar Regions: Impairment of hearing both ears.

5. The pain in the right iliac region (Chronic Appendicitis) was felt be ore entry into the service. This is exacerbated when he walks far distances. The pains in the lumbar regions and impairment of hearing of both ears begun after entry into the service. and on line of duty. These were due to the maltreatment he received from the Japanese last April 4, 1943 when he was a N.A. leader in San Pascual, Tuba and at the same time a member of the 14th Inf. He was suspected of having a contact with Lt. Aloot, Lt. Albert Osseo and Capt. Acop. The lumbar pains are exacerbated when hiking far distances.

3. Date of physical examination - Not examined because he is still sick in his house in Trinidad.

Basing from the finding of the attending physician I am of the opinion that the enlisted man will no longer be able to render military service, with the rigors attendant of military life.
