1. Submit your Report of Casualties from the day your troops become engaged with the enemy and submit it daily until the engagement ceases.

2. When action ceases, you may suspend the daily submission of your report. However, desire that you submit the report whenever there is a change in the entries of the last report. For instance, an FM gets sick and is brought to your Aid Station, one of the casualties "Remaining" as of your last report is returned to duty, is evacuated, or dies in your station. Continue the periodic submission of the report until your station is clear of casualties, that is, until all the "Remaining Cases" in your last report have been disposed of.

3. When engagement or action is resumed the report will be submitted daily according to instruction already issued.

4. Prompt submission of the report is desired. A consolidated weekly report of casualties will be prepared by this office for submission to higher Headquarters.
