

Subject: Enlisted Men Found Unfit for Military Service, Report of
To : The CO, 66th Inf, PA

1. The following Enlisted Men of the 1st Battalion, 66th Infantry, PA were found by me to be unfit for military service.

a. Name - Leon Amed - Rank - Sgt. Org - "A" Co, 1st Bn, 66th Inf, PA
Date of enlistment - July 9, 1942

Date of Physical examination - October 21, 1944

Nature of deformities - (1) ankylosis of right knee joint; (2) ankylosis of middle finger right hand.

Degree of disability - partial

(1) Ankylosis of right knee joint was contracted in line of duty as a result of an injury received on July 16, 1942; (2) ankylosis of middle finger right hand was contracted in line of duty/received on July 16, 1942.
as result of injury

b. Name - Carlos Dumasi Rank - Pvt. Org - "A" Co, 1st Bn, 66th Inf, PA

Date of enlistment - July 1944

Date of physical examination - Nov. 19, 1944

Nature of disease and deformity - (1) blurring of vision of right eye for both near and distant visions; (2) ankylosis of right knee joint.

Degree of disability - partial

(1) Blurring of vision of right eye existed prior to entry into the service, contracted not in line of duty; (2) ankylosis of right knee joint was contracted in line of duty as a result of injury received on August 21, 1944.

c. Name - Mariano Dilla Rank - Pvt. 1st Class Org - "B" Co, 1st Bn, 66th Inf

Date of enlistment - Oct. 8, 1942

Date of physical examination - Sept. 24, 1944

Nature of disease - Cataract of left eye

Degree of disability - partial

The condition was contracted in line of duty as a result of an injury received in Sept. 1942.

d. Name - Mariano Langone Rank - Pvt. Org - "C" Co, 1st Bn, 66th Inf, PA

Date of enlistment - 1943

Date of physical examination - Nov. 14, 1944

Nature of disease - (1) Frequent attacks of intensive headache, fever, dizziness especially on walking fast and long distance; (2) poor vision.

Degree of disability - partial

Both conditions are believed to be the result of a gunshot wound at the right temporal region of the head received in Bataan in March 1942, contracted prior to entry into the USAFIP but in line of duty at Bataan.

e. Name - Molintas Dahoy Rank - Pvt. Org - "C" Co, 1st Bn, 66th Inf, PA

Date of enlistment - Nov. 1942

Date of physical examination - Nov. 14, 1944

Nature of disease - (1) impairment of hearing of both ears and pain at both lumbar regions; (2) chronic appendicitis

Degree of disability - partial



(1) The impairment of hearing and the pains at the lumbar regions were contracted in line of duty as the result of maltreatment received from the Japanese on April 4, 1945; (2) The appendicitis existed before entry into the service and therefore not in line of duty.
