To : The Chief Surgeon, USAFIP, NL
Thru the Commanding Officer, 66th Infantry Pa

1. Request that 2 more Medical Officers be assigned to the Medical Company, 66th Infantry Pa.
2. The actual and effective strength of officers in the Medical Company is only 7 (6 MC and 1 MC). Whereas, by virtue of the Table of Organization, Medical Company, dated 9 April 1945, 9 officers (8 MC and 1 MC) is the authorized strength of officers.
3. At present the Medical Section attached to the 1st Bn, 66th Infantry Pa has only 1 Medical Officer, hence every battalion is supposed to have a Bn Surgeon and an Assistant Bn Surgeon. Lieut. Fernando P. Velasco, MC-PA, who has been attached and assigned to the said Bn is now on duty with the Base Hospital. The position of the Executive Officer, Medical Company and at the same time as an Assistant Regimental Surgeon assigned to Captain Mariano F Borja, MC-PA per Special Orders No. 205, HQ, USAFIP, NL, dated 10 September 1945 is left vacant caused by the relief and release of same officer from the service per Special Orders No. 228, HQ, USAFIP, NL, dated 3 October 1945.
4. The whole regiment is now bivouaced at Camp Purovir and the command is in dire need of 2 more Medical Officers to cope the situation in the installation and setup of the whole camp and to enable the Medical Company as a medical unit to render service to the regiment in line of its responsibilities, specific duties and definite functions in the best of its knowledge and capability.
5. Request then that assignment of 2 more Medical Officers be made.
