1. Be it ordered by this Headquarter that all dogs in your barrio be killed or exterminated until the 21st of September, 1944 without exception whatsoever.
2. Anybody who fails to comply with the order shall suffer punishment as the US Army authorities may direct.
3. Dogs to be killed or owner to be killed.

1. Be it ordered by this Headquarter that all dogs in your barrio be killed or exterminated until the 31st of this month, September, 1944, without exception whatsoever.

2. Anybody who fails to comply with the order shall suffer punishment as the US Army authorities may direct.

3. Said order shall take effect beginning the date of this order.
