REMARK SECTION

From Nov. 15, 1943 to March 15, 1944, the unef-signed was assigned to move with the 3 prisoners, Vicente, Ogoan, and Bruna and all the sick men at Dagdag to a safe place. This period inclusive had been devoted mostly to the attendants and care of sick men until their recovery.

I started with my few ~~guerrilla~~ men from the South to this place. Arrived on the 18th, and established the headquarter on the 19th of same month. Up to the end of March, the following aims were emphasized:

1. To enlist more men (soldiers & SS)
2. To arm the Hq. (Collecting of arms & Amunitions)
3. To attach to the troop, all separated men from their former Co's because of enemy raid.
4. To raid spica.
