GENERAL ORDER:

TO : All sentinels

My general orders are:

1. To take charge of this post and all Government property in view.
2. To walk in my post in a military manner, keeping always on the alert and observing everything that takes place within site or hearing.
3. To report all violations and orders I am instructed to enforce.
4. To repeat all calls from posts more distant from the guard-house than my own.
5. To quit my post only when properly relieved.
6. To receive, obey, and pass on to the sentinel who relieves, me all orders from the commanding officer, field officer of the day, officer of the day and officers and non-commissioned officers of the guard only.
7. To talk to no one, except in line of duty.
8. To give alarm in case of fire or disorder.
9. To allow no one to commit a nuisance on or near my post.
10. To call the corporal of the guard in any case not covered by instructions.
11. To be especially watchful at night and, during the time for challenging, to challenge all persons on or near my post, and to allow no one to pass without proper authority.
12. To salute all officers, and all colors and standards not cased.


