MEMORANDUM

To : All Unit and Company Commanders


1. Repeated complaints have been made with this Headquarters by American linemen of the 20th Infantry Signal Unit for the numerous cut telephone wires within the 3rd Battalion bivouac areas as well as along the highway adjacent to these areas.

2. While it is improbable that our men are tampering with friendly installations, it may be possible that such installations may be cut or otherwise destroyed by accident.

3. You are reminded that tampering with friendly communication lines and other military installations is punishable under the Articles of War.

4. You are therefore instructed to warn your men from tampering with military installations under pain of severe punishment or probable court marshal against violators of these instructions.


MEMORANDUM-


