GENERAL ORDER :
NO 1 :

1. Effective January 1, 1944; All commissioned personnel of the East Central Luzon Guerrilla Area will be brevited in the following Guerrilla rank in the Guerrilla Forces of the Commonwealth of the Philippines

Military Districts or Divisions and below:

- a. Commanding Officer and Chief of Staff— Colonel
- b. Assts. Chief of Staff(G-1, G-2, G-3, G-4)
and Regt. Commanders----- Lt. Col.
- c. Special Staff Officers; Regt. Exec. Officers
and Battalion Commanders----- Major
- d. Assts. to G-1, G-2, G-3, G-4; Assts. to
Special Staff Officers; Regt. Staff Offs;
Company Comdrs.; Liason Officers for Regt
and above; Message center Officers and Comdrs.
of Special Units----- Captain
- e. Executive Officers (Company and attached
Units) and 1st Aide to the Div. Comdr. -- 1st Lieut.
- f. Junior Officers (Company and attached Units)
and 2nd Aide to the Division Comdr.;
Division Operatives ----- 2nd Lieuts.

2. This order will apply only to these Officers who have been active in the Guerrilla Forces at least six(6) months prior to January 1st, 1944. (Guerrilla Forces comprehends active Guerrilla Units regardless of former or former affiliations).

3. All Officers who do not qualify under para. (1) and (2) supra, but are now on active service under this command will fall under the following classification until further orders:

- a. Former regular or reserve officers- regardless of present duty status will be brevited one rank higher than Army Commission. (Special Cases may be brought to the attention of this Hdqs.)
- b. All other cases- (1) Duty status of Company grade- brevited in rank.
(2) Duty status of Field Grade
- brevited one rank lower than present duty status.

4. All District Commanders will grade commissioned personnel within their capabilities and in cases of officers incapable of present rank and/or duty status will be responsible for re-ranking accordingly.


A N N O U N C E M E N T


2. The above mentioned Enlisted Man will report to the Commanding Officer of Company "B" for instructions immediately. Travel directed is necessary in the public service.
