REMARKS: April 21 4:00 A.M. Three Japs trying to penetrate our sector were killed. Most of the time we were on the alert.

Most of my men have only one pair of uniforms. It is requested that my men be furnished additional clothing so that they will not be forced to leave their post or be on AWOL.
