Reference is made to your letter of _____ wherein you again request information relative to your claim for arrears in pay.

The retained records of this headquarters reveal that you have been informed on numerous occasions that further correspondence with this headquarters on this subject would serve no useful purpose.

You are once again advised that the arrears in pay program terminated with the deactivation of the Adjustment Division on 31 December 1949. Subsequent to that date, the authority of this headquarters to determine or redetermine claims for arrears in pay and the authority to disburse United States Army funds appropriated for expenses of the Philippine Army ceased to exist.

In view of the foregoing, your case is definitely closed and further correspondence will NOT be answered.
