- 1. This morning, at about ten o'clock, a U. S. Army truck bearing No. 2206368 on its motor cover, stopped at the Poblacion of Polo, and two American soldiers sold to the public, particularly to the store owners nearby, American Goods. The truck was fully loaded, but not all of the goods were disposed of, because upon seeing that officers of this unit were inquiring the two aforesaid solders left.
- 2. The goods consisted of canned foods, cookies, assorted packs, etc.
