Memorandum for-All Bn & Unit Commanders, I PR

l.As per instruction of Lt Baffort, RPD, AFWESPAC, now at the Naguilian Bivouse Area, the processing of the 1st Pangasinan Regiment will start this morning, 19, Dec 45.

2. It is hereby directed that you must have all your men ready for the processing with all necessary papers anent their status on hand.

- 3. For the start, it is hereby directed that all Unit and En Commanders must immediately send to the RPD to day any number of EN in your respective units who are ready for the processing.
- 4. Incl is a Check Sheet from the RPD for your information and guidance. Form # 17 as stated in the heck Sheet will be furnished this Headquarters so you may come to this Office for particulars enent said form.
- 5. Please take immediate steps to recall all officers and Enlisted Men now out on pass to return immediately to Camp for the processing. In the meanwhile, all men now in Camp should get busy preparing their papers and every time they are made ready and alright with their respective papers should be directed and ordered to report to the Recovered Personnel Detachment immediately without delay.
- 6. It is hereby informed that the processing for the Rement will not be any longer be by units as this is found rather a delaying factor in the processing. So it is clear that any one from your respective units who has all papers ready for processing must be ordered to report to the RPD as directed.
- 7. All vivilians guerrillas are required to present their marriage certificate whether married before and after 1941. If no marriage certificate is available, accomplish an affidavit to that effect.


