

1. The following enlisted men of Company "E", 2nd Battalion, 1st Guerrilla Regiment, LGAF-USAFFE, who are ex-service men deserted as indicated below:

a. S-Sgt. ALBINO SINGSON, left company 1 April '45 without permission, brought firearm issued to him.

b. Pvt 1c1 SALVADOR YANGA, left company 23 April '45 without permission, brought firearm issued to him.

2. According to information, said enlisted men have already reported to the Philippine Army Replacement Camp at Camp Olivas, Panganga.

3. Request that this communication be forwarded to Philippine Army Headquarters. Said enlisted men should be arrested and brought to trial. As ex-service men, they should be fully aware of the seriousness of their offense, especially they deserted while their company was actively engaged in the front fighting the enemy. In my opinion, the cause of their desertion was not primarily the desire to report to Philippine Army Camp to draw their salaries and back pays but were scared to stay in the front, afraid to fight and die fighting. Such quality of soldiers does not speak well of the record of ex-service men who defended Bataan. They should be tried and if found guilty, punished.


