You are hereby promoted from SECOND LIEUTENANT to FIRST LIEUTENANT of the USAFFE Guerilla Forces, Western Luzon, Zambales, effective October 1, 1943, under the following oath:

"I, ULGARICO FRANCIA, Filipino citizen and of legal age, do solemnly swear under oath to uphold the Constitution and Government of the United States of America and those of the Commonwealth of the Philippines and to obey all promulgations and orders of my superior officers in accordance with the 96th Article of War.

"I further swear under oath that I shall not divulge the names of my co-patriots or secrets of the forces without express authority from my superior officers and for non-compliance of my duties, negligence or gross disobedience, I accept the penalty of immediate death.

"SO HELP ME GOD."



WE further swear not to DIVULGE the NAMES of OUR CO-PATRIOTS
and secrets of the ORGANIZATION without EXPRESS ORDERS from MY
SUPERIOR OFFICERS and any SLIGHT MISDEMEANOR or NEGLIGENCE or
NON-COMPLIANCE OF OUR duties WE accept the PENALTY AS provided
in the ARTICLES OF WAR.
