



MEMORANDUM for -
Lt FIDEL CONTRERAS, MC

1. Be informed that this Hqrs holds you responsible for the Carbine you allegedly turned over to Major OSMAN. The arm in question is a basic property of this CT, and only upon expressed consent of this Hqrs may you dispose of same. In the absence thereof, you are therefore bound to recover the arm or explain, to the satisfaction of this Hqrs, your failure to do so.
2. Previous to your alleged transfer of the arm in question to Major OSMAN, you had been clearly ordered to turn same over to this Hqrs. The fact that you ignored such order necessitates an explanation.
3. The temporary release from confinement, which is being granted you under the guarantee of Lt-Col MONTINOLA, shall not take effect until the above is duly accomplished.
