Subject: Supply-situation, data on the : G4 & DOM 7 MD.

1. In compliance with Memorandum dated Nov. 18 '44 the following information is hereby submitted:

(a) CURRENT STATUS OF SUPPLY: The Vallehermoso Area is mainly a source of Corn, Coconut-oil and Salt. The present stock of Corn is approximately 1,600000 Ears of which 600,000 Bars are stored in Bodegas directly under the supervision of this office, while abt. 1,000,000 Hars are stored at Hda. Pinucawan, an Army Project, supervised jointly by the Adm, Off, DOM Agents and this office. About 250 Frascos of Coco-oil and 20 cavanes of Salt monthly are presently being purchased in this area for immediate issue to the Adm. Off. Doll agents, who does the distribu-tion, mainly to the Dolf 72D. Only a limitted quantity of Livestoe is left, due to the fact that an intensive campaign for Livestock was conducted recently, when about 100 heads were procured.

(b) DEFINITE AREA COVERED: The VALLEHAM JOSO AREA, extending from Macapso, Tolo-tolo and Tranca in the North, to the Municipla Boundary between Vallehermoso and Guihulngan in the South. The Area-boundary to the West extends from Paliran through Guba to Calupa-an Diutay.

(c) ESTIMATED ARMY SHARE FOR DEC. JAN. HARVEST: About 400,000 Bars of Corn from the intire area including the Army Project at Panucawan. (The recent harvest has been very poor as compared with the Aug. Sept. harvest of last year, when a total of approximately 3 Million Mars were requisitioned and purchased in this same area.)
