RESIDENCE REQUIREMENTS FOR GRADUATION IN  
THE PHILIPPINE NORMAL SCHOOL FOR HIGH  
SCHOOL GRADUATES AND PROVINCIAL  
NORMAL SCHOOL GRADUATES

To Supervising Teachers and Principals:

1. The attention of all teachers who are graduates of a secondary course should be invited to the fact that under the present regulations at least 2 years of study in residence are required for graduation in the Philippine Normal School. It is desired that this information be furnished all teachers who are planning to continue in the Philippine Normal School. Consequently, work completed in the Cebu Summer School or in other summer schools can not be used to reduce the 2 years residence work required in the Philippine Normal School.
2. This information is published at this time at the request of the Director of Education to avoid any possibility of misunderstanding.

1928 PROVINCIAL ATHLETIC MEET AND ACADEMIC CONTEST

To Supervising Teachers and Principals:

1. Preparations for the provincial athletic meet and academic contest have been well started in most municipalities, but it is now time to begin to push the work with a view to accomplishing as much as possible during the seven weeks that remain. A special effort should be made by all teachers to arouse interest and enthusiasm in the local meets. Not only should the pupils be interested, but the public in general should be made to understand in order that they will become interested also. An effort should be made to get some of the people of every community to attend the meet in Dumaguete.

PROVINCIAL ATHLETIC MEET

2. Time, place and purpose - The provincial athletic meet will be held on November 29, 30 and December 1, 1928 on the Provincial High School athletic field, Dumaguete. Announcement of this meet was made in a memorandum to supervising teachers dated August 4, 1928. The primary purpose of holding the meet is to select athletes who will represent Oriental Negros at the coming meet of the East Visayan Athletic Association which will be held in Cebu during the latter part of December.
