MEDICAL SUPPLIES AND EQUIPMENT INVENTORY

To Supervising Teachers and Principals:

1. Hereafter all medical supplies and equipment in the barric schools not consumed during the school year are to be returned to the central school as soon as schools close in March.
2. When such property is returned to the principal, the teacher returning the same shall include a list of all the supplies so returned showing the approximate amount of each kind, care being exercised to list them correctly. The principal teacher will issue a receipt in favor of the teacher concerned, and the duplicate will remain with the supplies which should be kept in the central school medicine cabinet.
3. As soon as all the medical supplies and equipment are received by the principal from the different clinic and barric teachers of the municipality, he is to make a consolidated inventory using the attached Division Form No. IV-A. This annual inventory should be approved by the supervising teacher and forwarded to the Division Office when he submits his property inventory.
4. A sufficient quantity of the attached forms is being sent to the field to permit their use by clinic and barric teachers when they turn over their medical supplies and equipment to the central school principals at the end of the school year in order to facilitate the making of the principal's annual inventory.


